SECTION 7. Handling and storage

7.1. Precautions for safe handling

Safe use of the product

: Do not breathe gas.

Avoid release of product into atmosphere.

Use only properly specified equipment which is suitable for this product, its supply pressure

and temperature. Contact your gas supplier if in doubt. Avoid exposure, obtain special instructions before use.

Do not smoke while handling product. Avoid suck back of water, acid and alkalis.

Only experienced and properly instructed persons should handle gases under pressure. Ensure the complete gas system was (or is regularily) checked for leaks before use. Installation of a cross purge assembly between the cylinder and the regulator is

recommended.
