In case of liability for intent, gross negligence, non-performance of the agreed upon services or other legal reasons the claim for compensation is limted to the extend of actual damages.

The lecturer assures to the best of his knowledge that only material that is free of thirdparty copyright is used for the recordings, except if the provisions of copyright ("quotation right") have been adhered to. Should nevertheless exist third-party copyright in these materials the lecturer is required to immediately inform and release the University of Münster from any such claims.
