Evaluation and Portuguese grading system	<p>Each course unit is given a grade on a scale from 0 to 20. A minimum grade of 10/20 is required to pass each of the course units of the proposed programme.</p> <p>The overall classification derives from the relation between the distribution of the final grades of the cohort of students that graduated during the 5 previous years of the programme, and each student's final grade, along the intervals A, B, C, D and E. Each of these intervals includes, respectively, 10%, 25%, 30%, 25% and 10% of the cohort of students.</p>

Language requirements and teaching language	<p>Exchange students coming to the Faculty of Sciences are required to have, at least the A2 level (according to the CEFR) of Portuguese which is essential to properly attend lectures, mostly taught in this language.</p> <p>Students who do not have this level of Portuguese are strongly recommended to attend a Portuguese language course before arrival and during their stay.</p> <p>A good knowledge of English is also necessary (B1 is the minimum required level, which must be certified).</p> <p>Attention</p> <ul style="list-style-type: none">• BSc level courses are fully taught in Portuguese.• Postgraduate or Master programmes courses: If there are students who do not understand Portuguese, classes will be taught in English. <p>Examination in English should be arranged with each Professor upon the start of classes.</p> <p>The presentation of certificates and/or attested statements is <u>compulsory</u> (to be uploaded to the application):</p> <p>A2 level for Portuguese, in order to attend BSc level subjects;</p> <p>B1 level for English, in order to attend MSc level subjects.</p> <p>The lack of presentation of the appropriate certificate will result in an application rejection.</p> <p>Each application will be analyzed individually and your proposed plan of studies will be evaluated accordingly with your presented language level.</p>											
Learning Agreement for Studies												
<p>After the submission of the online application, students are required to send us a proposed study plan, duly approved and signed by the student and the responsible person at the sending University. This document must reach us until the application deadlines. We accept regular PDF Learning Agreements as well as Online Learning Agreements, through the EWP/Dashboard platform.</p> <p>Our office is not responsible for the signature/approval of Learning Agreements; each Department at our Faculty has an appointed Erasmus/exchange coordinator (https://ciencias.ulisboa.pt/en/erasmus).</p>												
Acceptance												
<p>Students are only accepted for a mobility period once they receive, on our behalf, an acceptance e-mail and the Learning Agreement for Studies/OLA duly approved by the responsible person. Only once they receive the formal acceptance they should start making their travel and accommodation arrangements.</p> <p>Upon arrival students are charged an administrative fee, which also contemplates accident and liability insurance during their stay, at our Faculty.</p> <p>All incoming students must be in possession of the European Health Insurance Card (EHIC) throughout their exchange.</p>
