Declaration

1. Granting of rights

The author grants the University of Münster – represented by the University Library (ULB) – the spatially and temporally unlimited, free of charge, irrevocable and non-exclusive right to electronically store, publicly disseminate, distribute, reproduce and archive the afore-mentioned publication along with metadata and abstract on the university's public server. The ULB shall archive and publish the electronic version on the internet, as long as technically feasible and reasonably practical.

The author agrees to release the bibliographic metadata including the abstract under the Creative Commons Zero licence (CC0, <https://creativecommons.org/publicdomain/zero/1.0/>).

2. Third-party Rights

The author certifies that they are the copyright owner of the publication, and that no copyright or licensing issues hinder its publication. The author guarantees that third-party rights (such as co-author, publisher, collecting society, or funding providers) are not infringed upon by the publication. Should third-party rights be violated, the author undertakes to protect the University of Münster against any resulting claims. The University reserves the right to claim recourse from the author in cases of demands arising from the publication. If any legal issues arise, the author must immediately inform the operators of the publication server. The ULB is authorized to restrict access to a document if concrete indicators suggest violation of third-party rights.

Only for edited works and works with several authors:

The signing author confirms that he/she has obtained permission from the authors involved in the work to use their contributions in the manner described above.

3. Data collection, data protection

The ULB Münster is entitled to gather and process personal data if necessary for fulfilling its responsibilities. Personal data are subject to data protection regulations.

4. Long-term archiving and dissemination

The author permits the ULB to transfer, entirely or partially, the rights granted to the ULB through this declaration to third parties without seeking further approval from the author. Simple usage rights may be granted to other libraries, archives, aggregators, open-access portals, and repositories, particularly to the Deutsche Nationalbibliothek and DFG specialist information services (FIDS), without requiring separate permission from the author.

5. Transformation of format

The author permits the ULB to perform future conversions of the document into other electronic and physical formats, such as for long-term preservation or accessibility purposes.

6. Copies

The author permits the ULB to provide users with full copies or portions of the work in printed form (print-on-demand) or on other media for private use. The ULB is allowed to delegate this service to third parties.

The copyright protections remain unaffected by this declaration. All remaining publication and usage rights, including the right to publish in printed form and on other publication servers, belong to the author.

7. Licence

To precisely define the usage conditions, the author can grant a licence for the publication. The Creative Commons licences or an individual licence are available for this purpose. (Further explanations of the licence agreements can be found in Appendix 3.) If no licence is granted for the work, copyright law applies

Important note: The information on these websites is for guidance only and does not exempt you from obtaining permission to publish in a specific case.

Appendix 3

Explanation of the licence of use

No licence

No special licence for use is granted. German copyright law (UrhG) therefore applies: Subsequent use is regulated by the so-called limitations of copyright law, which are set out in Sections 44a to 63a UrhG. If no licence is granted, no subsequent use in the sense of Open Access as outlined in the “Berlin Declaration on Open Access to Knowledge in the Sciences and Humanities”. We therefore recommend the use of a Creative Commons licence (see below). An exception is the cumulative digital dissertation, for which no free licence may be granted.

Individual licence

Specify this licence if your work has already been published under another licence or if you do not have the appropriate rights to grant a Creative Commons licence (e.g. if your publication is a second publication of an already published work).

Creative Commons licences

Creative Commons (CC) is a non-profit organisation founded in 2001. It publishes standard licence agreements with which an author can easily grant the public rights to use his or her works. The six core licences grant the general public, under certain conditions, rights of use for basically all known types of use as well as all previously unknown types of use.

A CC-licence can only be granted if the publication is not subject to any other rights of use (e.g. those stipulated in publishing contracts).

A total of six licences are available. ULB Münster recommends these two licences in particular:

- **CC-BY: Attribution**

This licence lets others distribute, remix, adapt, and build upon your work, even commercially, as long as they credit you for the original creation. This is the most accommodating of licences offered. Recommended for maximum dissemination and use of licenced materials.

- **CC-BY-SA: Attribution – Share Alike**

This licence lets others remix, adapt, and build upon your work even for commercial purposes, as long as they credit you and licence their new creations under the identical terms. This licence is often compared to “copyleft” free and open source software licences. All new works based on yours will carry the same licence, so any derivatives will also allow commercial use. This is the licence used by Wikipedia, and is recommended for materials that would benefit from incorporating content from Wikipedia and similarly licenced projects.

CC BY 4.0 – Attribution

Users may:

- reproduce, distribute and make the work or content available to the public.
- make modifications and adaptations of the work or content.
- use the work commercially.
- » the ideal CC licence for Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

CC BY-SA 4.0 International – Attribution, Share Alike

Users may:

- reproduce, distribute and make the work or content available to the public.
- make modifications and adaptations of the work or content.
- use the work commercially.
- » a CC licence that is very well suited to Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

- Share Alike: All new works based on yours will carry the same licence.

CC BY-ND 4.0 International – Attribution, No Derivatives

Users may:

- reproduce, distribute and make the work or content available to the public.
- use the work commercially.
- » a CC licence well-suited to Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

- No Derivatives: This work or content cannot be shared with others in adapted from.

CC BY-NC 4.0 International – Attribution, Non-Commercial

Users may:

- reproduce, distribute and make the work or content available to the public.
- make modifications and adaptations of the work or content.
- » a CC licence suitable for Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

- No commercial use: This work or content may not be used for commercial purposes and new works must also be non-commercial.¹

CC BY-NC-SA 4.0 International – Attribution, Non-Commercial, Sharing Alike

Users may:

- reproduce, distribute and make the work or content available to the public.
- make modifications and adaptations of the work or content.
- » a CC licence suitable for Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

- No commercial use: This work or content may not be used for commercial purposes and new works must also be non-commercial.¹

- Sharing Alike: All new works based on yours will carry the same licence.

CC BY-NC-ND 4.0 International – Attribution, Non-Commercial, No Derivative

Users may:

- reproduce, distribute and make the work or content available to the public.
- » a CC licence suitable for Open Access.

On condition that:

- Attribution: You must give credit to the author/rights holder in the manner specified by them.

- No commercial use: This work or content may not be used for commercial purposes and new works must also be non-commercial.¹

- No Derivatives: This work or content cannot be shared with others in adapted from.

¹ Caution: Many authors who intuitively choose an NC-restricted licence do so out of a desire to prevent the unwanted and uncontrollable commercial exploitation of their work. However, the NC restriction brings with it numerous, equally unwanted “side effects”.
